Your child explores his unique interests at his own pace with the encouragement of experienced, caring staff. Choose from two or three half-day programs with an open enrollment policy. Enroll now and watch your preschooler discover the world, practically in your own backyard!

Program Goals

- 1) Teach basic readiness skills in language arts and arithmetic.
- 2) To view children as competent and powerful learners, these programs build on each child's unique abilities and skills.
- 3) To provide a rich multi-sensory environment to promote, challenge and create learning opportunities.
- 4) To prove socialization and collaboration as an opportunity to develop skills to encourage cooperation and lifelong learners.
- 5) To promote families that are viewed as a true first teacher of children, these programs build on the culture, values and uniqueness within the classroom environment

Enrollment Requirements

Children must be toilet trained and at least 3 years old by September 1, 2016 or 4 years of age by September 1, 2016. A current physical is required. The health form (available at all sites, Wyoming Public Schools, and public health offices), including immunization records, and the original birth certificate will be requested by the first day your child attends class.

Refund Policy for Tuition Preschool Program

Wyoming Public Schools may need to cancel a preschool section due to low enrollment. If that occurs, parents will be offered enrollment in remaining sections or a full refund will be provided.

Withdrawal Policy for Tuition Preschool Program

If, for any reason, a parent chooses to withdraw their child from the preschool classroom, the parent must contact the preschool office located at Wyoming Public Schools, West Elementary, Early Childhood Center 1840 38th St SW, or phone 530-7533 or 530-7525. The child's name will be removed from the enrollment records at that time. It is also requested that the parent contact the child's preschool teacher and school office.

The refund policy for children who are withdrawn or removed from the program is as follows: Tuition is pro-rated based on the number of days of attendance or date of notification of leaving the program. There is also a \$25 processing fee for refunds.
