Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2018-19 educational progress for Wyoming Public School District and our schools. The AER addresses the complex reporting information required by federal and some requirements of state laws. Our staff or myself are available to help you understand this information. Please contact central office at 530-7550 for help if you need assistance.

The DISTRICT AER is available for you to review electronically by visiting the district website at [www.wyoming.k12.mi.us](http://www.wyoming.k12.mi.us) and clicking the Annual Education Report along the left-hand side, or you may review a copy in the main office at your child's school. In addition, for the district and each school you will have available the parent letter, school/district data, or the school/district improvement plan. Each school will also be communicating their own AER to parents directly. All the district and school annual education data reports are located at this Wyoming Public Schools website or at the Michigan website, MiSchool Data (<https://www.mischooldata.org/AER2019/CombinedReport2.aspx>).

These data reports contain the following information:

**Student Assessment Data** – Includes the following three assessments: M-STEP (Michigan Student Test of Educational Progress), MI-Access (Alternate Assessment), College Board PSAT 8/9 (replaced the English language arts and mathematics M-Step for all 8th graders), and College Board SAT. Presents assessment information for English language arts and mathematics for grades 3 to 8 and 11, and science for grades 4, 7, and 11, compared to state averages for all students as well as subgroups of students. The report helps users to understand achievement performance within grades and schools, and to make comparisons to district, state, and national achievement benchmarks.

**Accountability Scorecard – Detail Data and Status**

The accountability portion of the AER includes assessment proficiency and participation rates, graduation or attendance rates, as well as accountability index values showing school performance on a 0-100 scale.

**Teacher Qualification Data**

- Identifies teacher qualifications at district and school levels
- Reports percentage of core academic classes taught by teachers not considered highly qualified to teach such classes

**NAEP Data (National Assessment of Educational Progress)**

- Provides state results of the national assessment in mathematics and reading every other year in grades 4 and 8

Review the table below listing our schools. For the 2018-19 school year, schools were identified using the following definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no status label is given.
