Spotlight Presentation:

At the recent Board committee meeting, Gladiola Elementary principal Dana Stein, along with teachers and students, presented the Gladiola Student Council program and their initiative this school year, the Importance of Community. The group highlighted their efforts to celebrate and foster a positive school environment, emphasizing activities and programs designed to strengthen connections among students, staff, and the broader school community.

Wyoming Junior High School Building Spotlight Presentation:	Members of the Wyoming Junior High School Gaming Club and eSports Teams presented their afterschool programs to the Board on Thursday evening. Board of Education Interview Process Update:	The District completed interviews for the open Board of Education position, which was publicly posted on the District website seeking interested applicants. After reviewing all submitted materials and conducting candidate interviews on December 2nd, the district has extended an offer to a candidate to fill the vacancy for the term beginning January 1, 2026, through December 31, 2026.
Alpha Wolf 11 Celebration Reminder:	The Board was reminded of the upcoming Alpha Wolf 11 Champions of Character Celebration which is scheduled for Friday, December 12th at 12:30 PM in the gymnasium at Wyoming High School. Eight scholars will be surprised and celebrated as having demonstrated the distinguished character traits of an Alpha Wolf (kindness, compassion, and grace) and making a positive impact on their school community. Board members are encouraged to arrive by 12:15 PM to be seated prior to the ceremony.

<p>Finance Reports – October 2025: <b>Action Item – Approved</b></p>	<p>The Board reviewed and approved the October 2025 check register and budget to actual report.</p>
<p>Bond Authorizing Resolution: <b>Action Item – Approved</b></p>	<p>The Board reviewed and approved a resolution authorizing the sale of \$29,750,000.00 in bonds for construction related to the passing of the November of 2025 WPS bond proposals.</p>
<p>Section 31aa Funding Resolution D – Opt In Subject To Rescission: <b>Action Item – Approved</b></p>	<p>The Board reviewed and opted into a resolution (Resolution D) regarding Section 31aa funding for fiscal year 2025–2026. This resolution is designed to address the evolving circumstances created by ongoing litigation challenging the privilege-waiver requirement. Resolution D allows the District to provisionally opt in to 31aa funding by the December 4th deadline, preserving eligibility while the legal challenge proceeds. Should the litigation be unsuccessful and the privilege-waiver requirement remain in effect, the opt-in will be automatically rescinded, requiring the Superintendent to notify MDE of the rescission by December 30, 2025, at 11:59 PM, in the form and manner prescribed by MDE. This resolution ensures the District can maintain access to 31aa funding opportunities without waiving any privileges until the legal process is resolved.</p>
<p>2025-2026 Budget Amendment #1: <b>Action Item – Approved</b></p>	<p>The Board reviewed, discussed, and approved the 2025-2026 budget amendment #1.</p>
<p>WJH Gaming Club Movie Request: <b>Action Item – Approved</b></p>	<p>The Board reviewed and approved a request from the Wyoming Junior High Gaming Club to host a movie event featuring <i>Dungeons &amp; Dragons: Honor Among Thieves</i> (PG-13) as part of a celebration and community-building activity for both the WJH Gaming Club and eSports Team. The proposed showing would take place after school, with parent permission slips required for all participating students. The movie selection directly aligns with the Dungeons &amp; Dragons tabletop game the students have been actively engaged in during club meetings, providing a relevant and enriching extension of their shared interests.</p>
<p>WJH Scholar Trip Request – Michigan’s Adventure: <b>Action Item – Approved</b></p>	<p>The Board reviewed the travel request submitted by Wyoming Junior High School band scholars to travel to and from Michigan Adventure in Muskegon, Michigan on May 29, 2026 to participate in Performance At The Park. The trip is designed to provide scholars with the opportunity to perform at a public venue while fostering community and teamwork within the group. Scholars will participate in a fundraising campaign in February to support this event. This trip aligns with the performance standards outlined in the Michigan Merit Curriculum and offers an enriching experience for our scholars.</p>

<p>2026-2027 WJH New Course Proposals: <b>Action Item – Approved</b></p>	<p>The Board reviewed and approved the proposed 2026-2027 course additions and revisions for Wyoming Junior High School. Recommended updates include the removal of MySchool@Kent, the addition of EL English 3, and renaming Intro To Band as Beginning Band. A proposal to introduce a new Spanish Exploratory course was also presented for consideration.</p>
<p>2026-2027 WJH Curriculum Guide Updates: <b>Action Item – Approved</b></p>	<p>The Board reviewed and approved the 2026-2027 WJH Curriculum Guide, which included updates to course offerings at Wyoming Junior High School.</p>
<p>2026-2027 WHS New Course Proposals: <b>Action Item – Approved</b></p>	<p>The Board reviewed and approved the proposed 2026–2027 Wyoming High School course changes, which include several updates, additions, and removals. Recommended revisions include linking Testing Out and the Work-Based Learning Application processes, renaming Educators Rising to Rising Educators, and changing Digital Art to Digital Marketing &amp; Design. The course description for Personal Finance will also be updated. New courses proposed for addition are AW11 Scholar Leadership Academy, AP Business with Personal Finance, Business English, Sports Marketing, AP Cybersecurity, and AI Essentials. Courses proposed for removal include Art III, Studio Manager Independent Study, Introduction to Computer Science, Debate, Video Production 3, Accounting III, and Principles of Business.</p>
