Building Spotlight Presentation –  
Wyoming Junior High:

Wyoming Junior High School Principal Alex Schukow and teacher Jenna Veldboom were in attendance on Monday (03/14/22) evening to share the Wyoming Junior High School building spotlight presentation which overviewed building activities that took place during Black History Month.
