The group provided an overview of their class and staff charters, mood meters, and meta moments and how each has impacted their school community.

The Board reviewed and approved the Scholar First, Inc. consulting proposal for the 2024-25 school year. According to the proposal, The Scholar First, Inc. will consult and facilitate learning centered around the District strategic plan goals, create systems and structures for continuous improvement, provide principal/school leadership training, support implementation of new Essential Standards and High Leverage Teaching Practices, present as the

Wolf PAC keynote speaker, and lead in-person events that support District strategic plan goals.

The Board was provided an update on the 2023-24 budget.

**Donor Recognition:** 

Recently, Joe Steffes, WPS Safety and Security Coordinator, gave a presentation to the Wyoming Kentwood Chamber of Commerce. Following his presentation, several local businesses including LMCU, Tommy Brann, the Edward Jones Foundation, the Family Network, and Marge's Donut Den generously donated to scholars and families in need.

Two local foundations, the JETT (Jasper Endows Today and Tomorrow) Foundation and the Weller Family Foundation donated \$2,500 each in support of the District's new emergency safety backpack rollout.

Desktop Purchase: **Action Item – Approved**  The Board reviewed and approved a quote in the amount of \$75,699.96 for the purchase of thirty-six (36) Lenovo 2023 desktop computers to be used in the new Wyoming Junior High School computer lab and for teacher desktop replacements.

Chromebook Purchase: **Action Item – Approved** 

The Board reviewed and approved the CDW-G quote in the amount of \$316,790.00 for the purchase of one thousand one hundred seventy (1,170) Dell Chromebooks to be used as replacement devices for 1st, 5th, and 10th grade scholars.

Interactive Smart Board Purchase:

Action Item – Approved

The Board reviewed and approved a quote from Data Image LLC in the amount of \$64,775.00 for the purchase of twenty-five (25) new interactive smart boards to be used across the district. Summer School Update:

In the coming weeks, families will have the ability to register their K-6 scholars for the WPS summer school program. K-6 summer school will run Mondays through Thursdays beginning on Monday, June 3d and ending on Thursday, June 27th. Scholars will meet each day from 9 AM until 12 PM. Breakfast, lunch, and transportation are provided. Summer programming for our secondary scholars will be located at Wyoming High School beginning June 10. 7th and 8th grade scholars will be able to attend June 10 - 27. 9th - 12th grade scholars will be able to attend session 1 (June 10 - 27) and/or session 2 (July 8 - 25).
