It was resolved that the designated Electronic Officer (ETO) in accordance with Policy 6144, shall be the Associate Superintendent. It is resolved that designation of persons authorized to sign checks shall be the Associate Superintendent, Director of Finance, and Superintendent. Authority to sign vendor contracts shall be the Associate Superintendent and Director of Finance, authority to sign employment contracts shall be the Superintendent, Associate Superintendent, Director of Finance, and Director of Human Resources. The authority to sign purchase orders shall be the building/department administrator for an

WMHIP Resolutio Authorizing Meml Action Item – A	pership:	The Board reviewed and approved a resolution to authorize membership in the Western Michigan Health Insurance Pool (WMHIP), a Public Employer Pooled Plan (PEPP) established under the Public Employees Health Benefit Act, Act 106 of 2007. The Board and Superintendent reviewed the obligations and benefits of participation, including the WMHIP Amended Trust Agreement and Bylaws. If approved, membership in the WMHIP would be for a minimum of three years. The resolution would also authorize the Superintendent, Manager, or CFO to execute all necessary documents, and accepted WMHIP's provision of self-funded, pooled health insurance coverage. Conflicting prior resolutions were rescinded.
