The 18.0000 mills shall be used for general operating purposes (16.9508 regular mills and 1.0492 "Headlee Edge" mills).

BE IT FURTHER RESOLVED, that .4595 ad valorem mills, as reduced by impact of the Headlee Amendment (Article 9, Section 31 of the Michigan Constitution), shall be levied in 2024 on all property located within the Wyoming Public Schools. The .4595 mills, as reduced by the Headlee Amendment, shall be used for qualified sinking fund repairs and improvements.

BE IT FURTHER RESOLVED, that the Board of Education declares the millage rate of 5.65 mills be set against all property for debt retirement during the 2025-26 fiscal year (2025 tax year).

BE IT FURTHER RESOLVED, that no Board of Education member or employee of the school district shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board. Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision of the execution of the budget adopted by the Board and shall hold the department heads responsible for performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

BE IT FURTHER RESOLVED, that for purposes of meeting emergency needs of the school district, transfers of appropriations may be made upon the written authorization of the Superintendent. When the Superintendent makes a transfer of appropriations as permitted by this resolution, such transfer shall be presented to the Board of Education for consideration and adoption by the Board of Education.

This appropriation resolution is to take effect on July 1, 2025.
